## Nestle Donates Approximately \$280,000 to Meds & Food for Kids; St. Louis, Missouri-Based Organization Helps Children in Haiti

This is one of the largest contributions we've ever received and will directly support increased production and distribution of life-saving, nutritious food in Haiti. In addition, this donation will help fund Haiti's future with a new facility designed for safe food processing and large-scale production."

Nestle Purina PetCare Company President and Chief Executive Officer W. Patrick McGinnis plans to host a reception in March at Purina's St. Louis headquarters to congratulate Dr. Wolff and to further recognize the Meds & Food for Kids organization.
